$$\varphi(t) := b - \alpha \frac{\sigma_1}{\sigma} - \frac{\alpha^2}{\sigma^2} R_t$$

$$\psi(t) := \frac{\alpha R_t + \sigma \sigma_1}{\sigma^2}$$

$$\hat{X}_t = e^{\int_0^t \varphi(r) dr} \hat{X}_0 + \int_0^t e^{\int_s^t \varphi(r) dr} \psi(s) dY_s$$

$$= e^{\int_0^t \varphi(r) dr} \hat{X}_0 + \psi(t) Y_t - \int_0^t Y_s (\psi'(s) - \varphi(s)\psi(s)) e^{\int_s^t \varphi(r) dr} ds$$
